For payments by credit card a \$50 per person amount will be added to your invoice.

Your hotel (or similar): The Pez Espada was the very first luxury hotel on the Costa del Sol, opening its doors back in the glamour days of the 50's. A magnet for film stars and royalty, its guest book included the likes of Sean Connery, Sophia Loren and the King Juan Carlos of Spain. Photos of some of the most famous guest's line the hotel's aptly named 'Corridor of Fame'. And the most famous guest of them all, Frank Sinatra, even has a bar named after him. Fifty years on and this place is still just as popular as ever. In fact, it's what we call a repeat hotel – people just keep on coming back year after year. So, what's the secret to its success? As to the hotel itself, it's lovely. The bedrooms are fresh, modern and well-equipped and come with private bathroom with hairdryer. Further facilities include satellite TV, a direct dial telephone, safe box (for hire), a fridge/minibar and a balcony or terrace. The pool area is cocooned by lawns and gardens. Furthermore, there is a heated indoor pool, a sauna and a massage service on offer. Guests may make use of the tennis courts and guests may take advantage of the entertainment program. Here the food is top-notch. In fact, the Pez Espada's culinary credentials are probably its trump card. Not only are there tasty buffets mornings and evenings, but once a week there's a ritzy gala dinner.

ITINERARY

Day 1 - Depart the U.S.: from Portland airport via Air France/ Iberia Airlines (or similar) for Spain.

Day 2 - Costa del Sol: Welcome to the famous Costa del Sol, Spain's Mediterranean coastline! Upon arrival into Malaga, proceed to baggage claim and after clearing customs you will be met by your ABC Destinations representative. You'll be transferred to the four star Hotel Pez Espada located in the renowned resort town of Torremolinos, along one of the most cosmopolitan stretches of coastline in Spain. Spend the remainder of the day at leisure. Dinner is at the hotel. (D)

Day 3 - Costa del Sol/Seville: After breakfast at the hotel, take a full-day tour to Seville. Seville is Spain's fourth largest city and the capital of the Andalusia region. Built on the banks of the Guadalquivir River, the city has a rich Arab history and was once a prosperous trading port with the Americas. It was here in Seville that Columbus docked on returning from America. Enjoy a panoramic tour of this charming city; see the well cared for gardens at Maria Luisa Park, walk through the typical district of "Santa Cruz" and a visit to the Cathedral (15th C.). Enjoy the striking minaret, the slenderest tower in Muslim architecture "The Giralda", to which an exquisite bell tower was added in the 16th Century and not far away another amazing monumental complex to see, the Alcazar, an Arabic Palace, which was completed by Peter 1st and is recognized for its Mudejar style. (B, D)

Day 4 - Costa del Sol: After breakfast enjoy morning at leisure and relax at the hotel or you can take an optional tour to Tangier. Tangier is an unforgettable opportunity to visit this fascinating destination. The fun begins with a ferry ride across the straights of Gibraltar to exotic Morocco and the ancient city of Tangier. Upon arrival, we will tour of the modern half of the city along with Cape Spartel, the northwestern most point of the African continent. Next, you'll explore the old town or "Casbah" on foot! This is where shopping treasures abound in the myriad of colorful markets and meandering streets. Lunch is included today as no visit to Tangier would be complete without experiencing the wonderful cuisine of Morocco. (B, D)

Day 5 - Costa del Sol: After breakfast enjoy today at leisure or you can take an optional tour to Mijas. Here you'll be greeted by lovely whitewashed houses and spectacular views over the coast and countryside. Mijas is one of the most picturesque villages in Andalusia, seated 1300 feet above sea level. Perhaps you'll even want to experience a true local treat... a ride in a donkey-drawn taxi! or just relax at the hotel. (B, D)

Day 6 - Costa del Sol/Gibraltar: After breakfast, take a full-day tour of The Rock of Gibraltar. The Rock of Gibraltar is located at the entrance of the Mediterranean. Its strategic location and history have made it an international symbol of solidity and strength, and is frequently featured in the world press and media. Gibraltar is connected to Spain by a sandy isthmus. The subject of repeated conquest and sieges Gibraltar has been a British territory since 1704 when it was ceded forever under the Treaty of Utrecht. Since 1973 it has been a part of the EU under the British accession. When you first see the Rock of Gibraltar, whether it is from the air, from the sea or from either the Costa del Sol or the western end of the Bay, it is its impressive stature, towering isolated above the surrounding countryside, that causes the greatest impact. It has had this effect on people for many thousands of years. Return to the hotel for dinner. (B, D)

Day 7 - Costa del Sol/Ronda: After breakfast enjoy a full-day tour to Ronda. Explore the mountainous region of Ronda on this relaxing day trip from the Costa del Sol. You'll see all the highlights of the lovely town of Ronda, including the Plaza de Toros Maestranza, the Church of the Holy Spirit, the town square and a bull-fighting museum. The picturesque town of Ronda spans the plunging river gorge known as El Tajo, crossed by the impressive 18th-century Puente Nuevo Bridge. You'll visit the town square, known as Plaza de Espana, the Church of the Holy spirit, built in 1485, and the Cathedral Church of Our Lady of the Incarnation, known today as the Church of Saint Mary the Elder. Plaza de Toros, the oldest bull ring in Spain, has staged some of the most important events in bullfighting history. The museum's collection of memorabilia includes photos of famous bullfighting fans, including Ernest Hemingway and Orson Wells. You'll have free time to explore Ronda and perhaps enjoy lunch at a local restaurant before returning to your hotel on the Costa del Sol. (B, D)

Day 8 - Costa del Sol: After breakfast enjoy today at leisure, play a round at a local course, relax at the hotel spa, or do your last minute shopping or take an optional tour to Granada. Included is a guided tour of the "Alhambra", a fortified palatine city of the 13th to 15th century. Built by the Nazarite Kings, which also includes its Alcazaba Citadel and the Palaces of "Los Leones" and "Comares"; the Generalife, a summer residence set in beautiful gardens; the so-called Royal Room of Santo Domingo, built in the orchards of Almanxarra and the Palace of Alcazar Genil used by the Nazarite Queens. The Palace of Charles V, designed in 1526 by Pedro Machuca in the heart of the Alhambra as a symbol of new power, is the most outstanding Renaissance work in Granada. Make sure you have plenty of film for your camera! Return to the hotel for dinner. (B, D)

Day 9 - Costa del Sol/U.S.: After breakfast transfer to the airport for your return flight home. (B)

Please note: Though rare, it may be necessary to substitute hotels and adjust itineraries due to local conditions.
